

JOINT ELECTIONS AGREEMENT

This agreement is entered into by and between SCHLEICHER COUNTY, TEXAS, CITY OF ELDORADO, SCHLEICHER COUNTY INDEPENDENT SCHOOL DISTRICT, SCHLEICHER COUNTY HOSPITAL DISTRICT, and PLATEAU UNDERGROUND WATER CONSERVATION & SUPPLY DISTRICT acting by and through their governing bodies. The Joint Elections Administrator will function under the supervision of the Joint Elections Commission and Schleicher County will operate as the fiscal agent.

NOW, THEREFORE, in consideration of the premises, the County and political subdivisions do agree as follows:

1. CITY OF ELDORADO, SCHLEICHER COUNTY INDEPENDENT SCHOOL DISTRICT, SCHLEICHER COUNTY HOSPITAL DISTRICT, and PLATEAU UNDERGROUND WATER CONSERVATION & SUPPLY DISTRICT, each individually, agree to pay the sum of \$4,000.00 to the County to be applied towards the Joint Elections Administrator's office. The above stated amount may be paid in one lump sum during the 1st quarter of the calendar year, or will be billed, by request, at the beginning of each quarter. Payments will be made payable to Schleicher County.
2. CITY OF ELDORADO, SCHLEICHER COUNTY INDEPENDENT SCHOOL DISTRICT, SCHLEICHER COUNTY HOSPITAL DISTRICT, and PLATEAU UNDERGROUND WATER CONSERVATION & SUPPLY DISTRICT, each individually, further agree to pay, in addition to the annual amount set out above, all expenses of each election that any entity holds, including, but not limited to, election judges/clerks, ballots, software programming, supplies, newspaper publication(s), postage to send voting media to the vendor to code, postage to mail ballots by mail and lease of voting machines. Each political subdivision agrees to pay their pro-rata share directly to the election judges/clerks. All other expenses will be paid by the County then invoiced (each quarter) to each of the political subdivisions, as necessary.
3. The Joint Elections Administrator will be the Early Voting Clerk for any political subdivision holding an election. Voting by mail will be conducted by the Joint Early Voting Clerk.
4. In the event one or more of the political subdivisions cancels an election, the Joint Elections Administrator will be notified and the political subdivision will provide the "ORDER OF CANCELLATION" form to the Joint Elections Administrator. The Secretary of State will be notified by the Joint Elections Administrator of the cancellation.
5. All voting equipment, which is compliant with Section 61.012 of the Texas Election Code, will be provided by the County. The voting equipment will be tested by the Joint Elections Administrator prior to each election. The Joint Elections Administrator will tabulate and accumulate the votes after each election. The results will be provided to each political subdivision for canvassing.
6. If an election is held with a "City" political subdivision, the last two days of early voting will be from 7:00 am to 7:00 pm each day which will also include any other political subdivisions jointly holding an election with the "City".

7. The Annual Voting System Filing Report will be completed by the Joint Elections Administrator.
8. This agreement will be approved on an annual basis.
